PRIVACY POLICY

Effective Date: July 20, 2017

1. Acceptance

We have created this Privacy Policy (the "Policy") because we value users' privacy. The Policy describes the types of information we may collect from you, or that you may provide, when you access ReMail (the "App"). This Policy does not apply to information collected by any third party, including through any external website that may link to or be accessible from the App. Please check directly with each such third party its Privacy Policy, to avoid unfair surprises and misunderstandings.

Your use of this App constitutes your acceptance of this Privacy Policy. If you do not agree with this Privacy Policy, you may not use our App. This Policy may change from time to time, and the date of last update is indicated at the top of this page. Your continued use of this App after we revise this Policy is deemed to be acceptance of the revisions, so please check this page from time to time for updates.

2. What information we collect

We may collect several types of information from and about users of our App, including the following:

- a. Personal Data: Name, email address and contents, location, phone number, credit card/PayPal info, Google authentications in all the functionalities that ReMail has access to and is authenticating for as listed in the Google authentication page, contacts from user's Google account.
- b. *Voluntary Data*: Information you voluntarily provide to the App or when you contact us for any reason.

We collect this information:

- c. Directly from you when you provide it to us (e.g. when you contact us for any reason).
- d. Automatically as you navigate through the App.
- e. When you post or share content (e.g., listings, reviews, public questions etc.).

3. How we use your information

We use information that we collect about you or that you provide to us, including any personal information:

- a. To provide the services you requested.
- b. To notify you about changes to our App or any services we offer or provide though it.
- c. To carry out our obligations and enforce our rights.
- d. In any other way we may describe when you provide the information.

4. <u>Disclosure of your information</u>

We do not sell any of your personal information to 3rd parties. We may disclose personal information that we collect or you provide as described in this Policy:

- a. To fulfill the purpose for which you provide it.
- b. To contractors, service providers and other third parties we use to support our business.
- c. To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution or other sale or transfer of some or all of the App's assets, whether as a going concern or as part of bankruptcy, liquidation or similar proceeding, in which personal information about our App users is among the assets transferred. In case of such business transition, you will be notified via email and/or prominent notice on our website for 30 days of any such change in ownership or control of your personal information. If you are not happy with the Privacy Policy of the new owner, you may stop using the service and notify not to use your personal information and de-activate/terminate your account.
- d. For any other purpose disclosed by us when you provide the information.

We may also disclose your personal information:

- f. To comply with any court order, law or legal process, including to respond to any government or regulatory request.
- g. If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the App, our customers or others.

5. Data security

Personal information you provide to us is stored on a password protected server accessible only by administrator. However, we cannot guarantee the security of your personal information transmitted to our App because any transmission of information over the Internet has its inherent risks. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the App. You are responsible for keeping your login credentials, if any, confidential.

6. Children's Privacy

Our App is not directed to children under the age of 13. We do not knowingly collect any personal information about children under the age of 13. If we obtain actual knowledge that we have collected personal information about a child under the age of 13, that information will be immediately deleted from our database.

If a parent believes that his or her child has submitted personal information to us, he or she can contact us via e-mail. We will promptly delete the information upon learning that it relates to a child under the age of 13. Please note that it is possible some of this information may remain archived in web logs and back-up archives after we delete the information from our active database.

7. Accessing and correcting your personal information
